CHARGE I: Violation of the UCMJ, Article 92

Thompson to have no contact with [REDACTED] either directly or indirectly, an order which it was his duty to obey, did, on divers occasions within the State of Colorado, between on or about 13 August 2015 and on or about 30 November 2015, fail to obey the same by wrongfully having contact with [REDACTED].

CHARGES AND SPECIFICATIONS

CHARGE II: Violation of the UCMJ, Article 120

Specification 1: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, did, at or near Schriever Air Force Base, Colorado, between on or about 1 November 2014 and on or about 31 January 2015, commit a sexual act upon [REDACTED], to wit: penetration of her vulva with his penis, by unlawful force, to wit: holding her against the wall and floor using physical strength or violence.

Specification 2: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, did, between on or about 1 October 2013 and on or about 5 May 2015, within the State of Colorado, commit sexual contact upon [REDACTED], to wit: touching [REDACTED] breast and buttocks with an intent to gratify his sexual desire, by causing bodily harm to her, to wit: committing the said sexual contact without [REDACTED] consent

Specification 3: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, did, on or about 2 July 2015, within the State of Colorado, commit sexual contact upon [REDACTED], to wit: touching [REDACTED] breast with an intent to gratify his sexual desire, by causing bodily harm to her, to wit: committing the said sexual contact without [REDACTED] consent.

CHARGE III: Violation of the UCMJ, Article 128

Specification: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, did, within the State of Colorado, on or about 10 July 2015, unlawfully grab [REDACTED] on the arm with his hand.

CHARGE IV: Violation of the UCMJ, Article 133

Specification 1: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, did, within the State of Colorado, on or about 10 July 2015, wrongfully and dishonorably falsely imprison [REDACTED] [REDACTED], to wit: confine or detain [REDACTED] without her consent and without proper legal authority, such conduct being unbecoming of an officer and gentleman.

Specification 2: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, did, within the State of Colorado, between on or about 1 July 2014 and on or about 15 July 2015, wrongfully and dishonorably hold his erect penis in his hand while in uniform and seated in his office, and proceed to take a picture of himself holding his erect penis while in uniform and seated in his office, such conduct being unbecoming of an officer and gentleman.

CHARGE V: Violation of the UCMJ, Article 134

Specification 1: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, a married man, did on divers occasions, within the State of Colorado, between on or about 1 December 2013 and on or about 11 July 2015, wrongfully have sexual intercourse with [REDACTED], a woman not his wife, such conduct being of a nature to bring discredit upon the armed forces.

Specification 2: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, a married man, did on divers occasions, within the State of Colorado, between on or about 1 October 2013 and on or about 11 July 2015, wrongfully have sexual intercourse with [REDACTED], a woman not his wife, such conduct being of a nature to bring discredit upon the armed forces.

Specification 3: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, a married man, did on divers occasions, within the State of Colorado, between on or about 1 September 2013 and on or about 30 November 2014, wrongfully have sexual intercourse with [REDACTED], a woman not his wife, such conduct being of a nature to bring discredit upon the armed forces.

Specification 4: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, a married man, did on divers occasions, within the State of Colorado, between on or about 1 March 2014 and on or about 30 November 2014, wrongfully have sexual intercourse with [REDACTED], a woman not his wife, such conduct being of a nature to bring discredit upon the armed forces.

Specification 5: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, a married man, did on divers occasions, within the State of Colorado, between on or about 5 December 2014 and on or about 13 October 2015, wrongfully have sexual intercourse with [REDACTED], a woman not his wife, such conduct being to the prejudice of good order and discipline in the armed forces and of a nature to bring discredit upon the armed forces.

Specification 6: In that COLONEL EUGENE MARCUS CAUGHEY, United States Air Force, Headquarters Air Force Space Command, Peterson Air Force Base, Colorado, a married man, did, on Schriever Air Force Base, Colorado, between on or about 23 April 2014 and on or about 31 January 2015, wrongfully have sexual intercourse with [REDACTED], a woman not his wife, such conduct being of a nature to bring discredit upon the armed forces.
