FINDINGS AND ORDER

### **FINDINGS**

The Court finds that public release of the search warrant and its accompanying documents could compromise this law enforcement investigation by causing the search or related searches to be unsuccessful, create a substantial risk of injury to an innocent person (s), or severely hamper this ongoing investigation.

### **ORDERS**
